All audition rounds are held behind a screen. The audition committee of the NHSO reserves the right to immediately dismiss any candidates not meeting the highest professional standards. Qualified musicians may be placed on the substitute/extra list. Auditioning candidates must be eligible to work legally in the U.S. and non-US citizens must show work permission before being invited to audition.

Contract Information

In addition to its eight Classics Series concerts, the NHSO annually produces three Pops programs, Young People's concerts, outdoor concerts in the summer, and other special concerts and educational services. Rehearsals are usually held on consecutive weekday evenings (and some weekends) in the day(s) immediately prior to the performance day.

The pay for the 2025-2026 season is \$191.70 for principal and \$142.00 for section positions. If a current NHSO member is awarded the principal position at this audition, then an additional section position may be awarded. The principal position is offered to begin starting with the 2026-2027 season on July 1, 2026. The section positions are offered for the remainder of the 2025-2026 season beginning April 2026. Since they are offered after the start of the season, the guaranteed services and required minimums only take effect beginning on July 1, 2026 for the 2026-2027 season. Contracted members are required to play a minimum number of series per season depending on the number of series offered. The NHSO is a part-time per service orchestra, offering on average 35-50 services per season. In addition, there is a travel pay allowance for players living more than 15 miles from New Haven (maximum of \$40 per day).

The substitute list may be updated with results from any audition. To perform with the New Haven Symphony Orchestra, you need to be a member in good standing with your local musicians' union (A. F. of M.). If you are offered more than 6 services within a season you must join local 400, even if you are a member of another local.
