### **Bass Audition:**

All applicants must register with the Auditions Supervisor by e-mailing the applicant fact sheet and one page resume prior to auditioning. Bassists auditioning for the Navy Fleet Bands must audition on Electric Bass. Please bring to the live audition your own copies of music and backing tracks. Our auditions are designed to represent a variety of musical styles that you could potentially perform in a Fleet Band. A small speaker will be provided for backing tracks and a PA speaker with XLR and 1/4" inputs will be provided for instrument amplification. Applicants are encouraged to provide their own amplifiers if possible.

Prescreens are available but not mandatory. Based on a limited amount of audition slots, a prescreen may be required. Please contact the Auditions Team for submission details.
