Because Little Voices (name of franchise) provides tuition for pupils aged 4 - 18 years,both in school and out of school settings they are obliged to ensure that all tutors, assistants and individuals working with Little Voices are not by virtue of the Childcare (Disqualification) Regulations 2009 ("the Regulations") and the statutory guidance of the Department for Education entitled "Keeping Children Safe in Education" disqualified from working with children.

Section 1 – Orders or other restrictions
