- Rehearse with the Director (including Staff Directors, Choreographers, Fight Arrangers etc.) in rehearsal rooms, studios, on stage, or at any other venue
- Rehearse and perform in London, as well as other locations, including touring in the UK and abroad as required
- Undertake recordings for audio/visual use within ENO live performances, and to take part in audio/ visual recordings and relays of rehearsals and performances
