

Key Duties:

- Rehearse, sing, perform (including acting and dancing) and understudy (including all staging requirements)
- To participate in all chorus work including work with ENO Engage (ENO Learning & Participation Programme)
- Prepare and learn music as necessary and appropriate; rehearse music as required during music and / or production / stage calls
- Rehearse with the Director (including Staff Directors, Choreographers, Fight Arrangers etc.) in rehearsal rooms, studios, on stage, or at any other venue
- Rehearse and perform in London, as well as other locations, including touring in the UK and abroad as required
- Undertake recordings for audio/visual use within ENO live performances, and to take part in audio/visual recordings and relays of rehearsals and performances
- Maintain their voice to an optimum professional standard
- Wear costume, wigs and make up when and as directed at stage rehearsals and performances; wear rehearsal/practice costumes as necessary at production rehearsals
- Undertake wigs and wardrobe fittings as required
- Take part in ENO concerts, and other events promoted by ENO, or its subsidiary companies
- Undertake training and development
- Participate in appraisals
- Undertake, where required, a variety of chorus duties during any call
- Undertake any other appropriate duties as defined by the Chorus Manager.

The Chorister will have the opportunity to be considered for small roles and covers which will include coaching with ENO Music Staff.

All applicants should have a high standard of singing, be able to read music and have some stage experience with the potential to develop further in the opera industry.

- Detail any relevant training, experience, or interest in working within Engagement/Outreach/Teaching environments. Particular focus on any experience of working with primary, secondary, higher education groups, SEND children and groups of disabled adults or adult community groups
