# SUB-PRINCIPAL SECOND VIOLIN TUTTI SECOND VIOLIN

The CBSO is seeking to appoint two positions to our Second Violin Section:

#### **Sub-Principal Second Violin**

The successful candidate will play as required by orchestration, sitting up to and including leading the section. This position rotates with two other sub-principal players for full orchestra repertoire, and there are opportunities for the successful candidate to lead small ensemble projects.

#### **Tutti Second Violin**

The successful candidate will play as required by orchestration, sitting up to and including No.3 in the section. This position rotates with other tutti players for full orchestra repertoire.

SALARY: £38,181 per annum HOURS: 208 days per year

### **ABOUT THE CBSO**

The City of Birmingham Symphony Orchestra (CBSO) is the flagship of musical life in Birmingham and the West Midlands, and one of the world's great orchestras.

Resident at Symphony Hall in Birmingham, the orchestra performs over 150 concerts each year in Birmingham, the UK and around the world, playing music that ranges from classics to contemporary, film music to symphonic disco, and everything in between. With a far-reaching community programme and a family of choruses and ensembles, it is involved in every aspect of music-making in the Midlands. But at its centre is a team of 90 superb professional musicians, and more than 100-years of making great music in the heart of Birmingham.

That local tradition started with the orchestra's very first symphonic concert in 1920 – conducted by Sir Edward Elgar. Ever since then, through war, recessions, social change and civic renewal, the CBSO has been proud to be Birmingham's orchestra.

Under principal conductors including Adrian Boult, George Weldon, Andrzej Panufnik and Louis Frémaux, the CBSO won an artistic reputation that spread far beyond the Midlands. But it was when it discovered the young British conductor Simon Rattle in 1980 that the CBSO became internationally famous – and showed how the arts can help give a new sense of direction to a whole city.

Rattle's successors Sakari Oramo, Andris Nelsons and Mirga Gražinytė-Tyla helped cement that global reputation and continued to build on the CBSO's tradition of flying the flag for Birmingham. Now, under the dynamic leadership of Kazuki Yamada, the CBSO continues to do what it does best – playing great music for the people of Birmingham, the Midlands, and beyond.



### OTHER OPPORTUNITIES

#### LEARNING AND ENGAGEMENT

The CBSO offers a range of Continuous Professional Development opportunities for its musicians, which includes the opportunity to engage with the CBSO's Learning and Engagement Programme. The L&E programme works with a broad and diverse range of participants through projects in primary, secondary and special schools, care settings and community venues. We support talented young musicians through our partnership projects with the Royal Birmingham Conservatoire, the CBSO Youth Orchestra and side-by-side orchestra days. A variety of training opportunities are available for CBSO players to help support these projects.

#### **CHAMBER MUSIC**

There are extensive chamber music opportunities in our player-led Centre Stage series and small ensemble performances, performing to range of different audiences at the CBSO Centre and across the region.

#### INTERNATIONAL TOURING

The orchestra enjoys regular high-profile international touring as part of its varied schedule, making it one of the most globally active of the UK's regional orchestras. Recent international touring destinations have included the United States, Japan, and many of Europe's finest concert halls.

- Recent orchestral experience as a professional violinist
- Commitment to delivering a very high standard of work
- Excellent communication and organisational skills
- Self-motivated, reliable and able to work under pressure
- Ability to work co-operatively as part of a team
- Ability to develop positive working relationships including with other members of the orchestra and staff
- Respect for others demonstrated by being fully prepared to play at the start of every session
- Ability to understand and speak English

#### Desirable:

- Proven expertise in a broad range of musical and performance activities including education work and chamber music
- Considerable recent orchestral experience as a professional violinist
