MASTERCLASSES AND CONCERTS

(Formerly Chopin Sessions)

Welcome to the Mallorca Piano Days (formerly Chopin Sessions), an event dedicated to young pianists seeking artistic guidance from renowned professors and concert pianists.

For the 2026 edition, we are thrilled to offer an expanded two-session format featuring esteemed professors.

1. LOCATION AND DATES

The Mallorca Piano Days 2026 will be held in Felanitx, Mallorca, at the **Conservatorio Profesional de Música de Felanitx** (Rector Planes 38, 07200 Felanitx).

- **Masterclass Dates:** September 13th – 20th, 2026
- **Session 1 Arrival:** September 12th
- **Session 1 Departure:** September 17th
- **Session 2 Arrival:** September 16th
- **Session 2 Departure:** September 21st

2. RULES OF PARTICIPATION AND FEES

Participants may choose to attend a single session or maximize their experience by attending both. There is no age limit, but the number of active participants is limited.

Participation Packages

Package	Fee	What is Included
Single Session	350 €	3 lessons of 50 minutes (1 with each professor in the session), practice facilities, and a diploma of active participation
Both Sessions	650 €	6 lessons of 50 minutes (3 per session, ensuring time with all professors), practice facilities, and a diploma of active participation
Extra Lesson	120 €	1 additional 50-minute lesson with a professor of your choice (subject to availability)

General Conditions

- **Repertoire:** Participants must prepare at least 20 minutes of solo piano works ranging from the Baroque era to the 20th century
 - **Selection Process:** Admission is based on the artistic and pianistic level proven in the submitted recordings. In case of a tie between applicants of a comparable level, the application submission date will be used as the deciding factor
 - **Extra Lessons:** Due to potential high demand, the organizers reserve the right to limit the number of extra lessons a student can book

3. APPLICATION PROCESS & RECORDINGS

Candidates must complete the [APPLICATION FORM](#) and provide a link to their audition recording.

Recording Requirements

- The recording must be 7 to 15 minutes in length (video)
- It must contain one or more solo pieces by any prominent classical composer
- The file must be of decent audio quality (please use uncompressed or lightly compressed formats)
- Upload your file to a hosting service (e.g., YouTube or WeTransfer) and include the link in your Application Form
- *Exemption:* Candidates who have actively participated in previous editions (formerly Chopin Sessions) are not required to submit a new recording

Important Dates and Deadlines

- **June 14, 2026:** Final deadline to submit the Application Form and recording link
- **June 21, 2026:** Candidates will receive an email confirming their acceptance or rejection
- **June 30, 2026:** Deadline to transfer the initial €200 deposit to secure your spot
- **August 20, 2026:** Deadline to transfer the remaining balance of your chosen course fee (€150 for a single session, or €450 for both sessions)

Payment Instructions

4. TRAVEL, ACCOMMODATION, AND MINORS

- **Travel & Expenses:** All costs related to traveling to and staying in Felanitx (transportation, accommodation, daily living expenses, and health/travel insurance) are the sole responsibility of the participant.
- **Underage Participants:** For any participant who is a minor, a parent or legal guardian declares their agreement that the Conservatorio Profesional de Música de Felanitx cannot assume responsibility for supervising the underage student. This applies strictly to behavior before the beginning and after the end of the daily classes, as well as anywhere outside the official masterclass rooms. The parent or legal guardian bears full responsibility for any damage caused by the underage participant.

5. LIABILITY

Participation in the Chopin Sessions occurs at the participant's own risk. Participants are responsible for damage which they may cause.

6. SEVERABILITY CLAUSE

If individual terms of these terms and conditions are or become ineffective, the validity of the other terms of these general conditions are not thereby affected. The ineffective term is replaced by a substitute provision which comes closest to the intended regulation.

7. GDPR

In accordance with the provisions of the General Data Protection Regulation (GDPR), which regulates the right to information in the collection of data, we inform you of the following points:
