8. Qualifying Round August 18-19: piano rehearsal with pianist and singers

Final Concert and Award Ceremony August 21 Teatro Sociale di Camogli at 9:00 PM  
  
On the morning of August 21, each finalist will have 30 minutes of solo rehearsal with the orchestra and singers.  
  
The judgment of the individual tests will be published on [www.spaziomusica.org](http://www.spaziomusica.org)
9. The winners will be the candidates who have achieved the best score, which cannot be lower than 9/10. The Judgment of the Jury is final and unappealable. The first prize winner, under penalty of forfeiture of the prize itself—which in such case will remain unassigned, meaning that subsequent positions in the ranking will remain unchanged—must without fail guarantee their presence in Camogli from August 22 to 27 inclusive for rehearsals with the orchestra and singing company aimed at the production of the first performance of the show (August 27).
10. The winners of Special Prizes will be chosen at the sole discretion of the prize provider.
11. For any and all legal disputes arising within this competition, the Court of Genoa shall have exclusive jurisdiction.
